- 2. Bring the entire box at one time, after all items have been purchased.
- 3. **<u>NO SUBSTITUTIONS!</u>** Do not mix items from different boxes.
- 4. Get **<u>REGULAR SIZED</u>** products unless specified otherwise.
- 5. No dented cans, open products, or half used products. The products must be <u>NEW AND</u> <u>UNOPENED</u>.
- 6. Each box is worth 5 hours of community service work.

(If you have $\underline{50}$ hours of community service work, you may substitute $\underline{6}$ boxes for $\underline{30}$ hours.) (If you have $\underline{30}$ hours of community service work, you may substitute $\underline{4}$ boxes for $\underline{20}$ hours.)
